HEALTH AND SAFETY AGREEMENT

Italcultura (herein referred to as "IC") is committed to providing its students, teachers, guests (herein referred to as "Member or Members") and employees with an environment that is as clean and safe as reasonably possible. The cooperation of our Members is required to best achieve this goal. To that end, in consideration of accessing ItalCultura and its premises, classrooms, language classes, events, equipment, supplies and services, (herein collectively referred to as the "Facilities"), we ask Members to acknowledge and agree with the content of the present Health and Safety Agreement as follows:

A. Member understands that other Members, guests and staff will have access to the Facilities. While IC takes reasonable steps to ensure the safety and sanitization of the Facilities, Member acknowledges that IC cannot and does not guarantee that the Facilities are germ/virus free (this includes, but is not limited to COVID-19).

B. Member agrees: (1) to submit, at the moment of enrolling in any language class, the C.D.C. Covid-19 vaccination card, showing proof of full vaccination, according to [C.D.C. guidelines](#); (2) the wearing of a face covering within the Facilities is recommended; (3) that the Member may be denied access to and use of the Facilities unless Member truthfully confirms that he or she is feeling well, does not have signs and symptoms of COVID-19, and has not knowingly been exposed in recent days to a person diagnosed with COVID-19; (4) if required, to have his or her temperature taken by an IC employee upon entering the Facilities and if his or her temperature is equal to or greater than 100.4 degrees, he or she will not be admitted to IC on that day; (5) to not seek entry into IC and attend its classes if Member feels sick or exhibits any of the signs or symptoms of COVID-19; (6) to immediately inform IC staff if Member feels sick, exhibits any of the signs or symptoms of COVID-19 or is diagnosed with COVID-19; (7) to adhere to any health, safety, social distancing and protective guidelines established by IC or C.D.C., W.H.O., State of Illinois or other federal, state or local governmental agency.

C. Member understands, acknowledges and agrees that access to and use of the Facilities by Member is voluntary and involves inherent risks. As material consideration for access to and use of the Facilities, Member agrees to specifically assume all risks of personal injury, illness and death, property loss and other damages including, without limitation, risks of contracting COVID-19 or other bacterial or viral illnesses, and Member hereby releases, waives, discharges and covenants not to sue IC and their respective officers, directors, managers, owners, partners, employees and agents (herein referred to as "IC Parties") for any and all claims, liabilities, losses, costs, damages and expenses that the Member may raise against IC/IC Parties for any personal injury, illness or death, property loss or other damages connected to or arising out of the associated risks. Any dispute between Member and IC/IC Parties under this Agreement will be resolved by arbitration in Chicago, Illinois in accordance with the rules of the American Arbitration Association.

Signatures to this Agreement transmitted by electronic means (including facsimile transmission or electronic mail transmission of a portable document format document) or affixed as an electronic signature shall be deemed and treated as original signatures and shall be valid and effective to bind Member to this Agreement.
